Contra Costa County Schools Insurance Group CPI Nonviolent Crisis Intervention Training



The principles and techniques taught in the Nonviolent Crisis Intervention program have proven effective in resolving potentially violent situations. By participating in this program, you will gain the confidence necessary to handle crisis situations with minimal anxiety and maximum security. The training will help you intervene more safely when behavior becomes dangerous. And, most importantly, it will not damage the professional bond you've worked so hard to establish with the individuals in your care.

- * Customizable to each district and occupation
- * Interactive and fun; variety of teaching tools used

Nonviolent Crisis Intervention Training includes a combination of lecture and instructor-led group activities which provides opportunities for participants to discuss and practice key concepts while learning proven, practical skills to de-escalate disruptive or assaultive students. **Trainings are held at CCCSIG, 550 Ellinwood Way, Pleasant Hill, CA.**

NEW: Additional tools and concepts for verbal interventions and physical techniques for personal safety and control.

Participants will be able to:

- * Identify behaviors that could lead to a crisis
- * Effectively respond to certain behaviors that will prevent the situation from escalating
- * Use verbal and nonverbal techniques to defuse hostile behavior
- * Resolve a crisis before it becomes violent

Program cost: No cost to member districts (a \$999 value per attendee!).

Additional information:

- * The CCCSIG Instructor is certified by The Crisis Prevention Institute
- * A minimum of 10 attendees is required; maximum 20 per class
- * CPI workbook and certification card provided to each participant
- * We offer the full, six-hour (no control positions) or the full, eight-hour (with control positions) training; AND, the refresher, four-hour training. Employees who wish to take the refresher training must possess a current Nonviolent Crisis Intervention/CPI certification.

Room & A/V Requirements: A minimum of 1,500 square feet in order to have sufficient practice area for the personal safety and physical intervention exercises and a projector screen.

Attire: Comfortable clothes and flat, closed-toe, non-skid shoes.
